2. The Short List is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

3. The candidates who have secured 52.00 marks and above are included in the Main List of the Short List. The required cutoff marks have been lowered to the extent necessary in respect of the Supplementary Lists.

4. The candidates belonging to Other Backward Classes included in the Short List who are required to produce Non-Creamy Layer Certificate as per G.O(P) No: 81/09/SC/ST/DD dated 26.09.2009 shall produce the same along with other documents mentioned above or as and when called for. Such candidates in the main list who fail to produce the required Non-Creamy Layer Certificate will not be entitled to the benefit of Community reservation and will be considered as Open Competition candidates

5. SC/ST candidates included in the Short list are required to produce 2 copies of self-attested Caste Certificate obtained from the Revenue Authorities not below the rank of Tahsildar issued to be produced before the Kerala Devaswom Recruitment Board. Such candidates in the List who fail to produce the required community certificate will not be entitled to the benefit of Community reservation and will be considered as Open Competition candidates.

6. As regard to candidates in the Supplementary Lists of Other Backward Classes, Schedule Caste and Schedule Tribe, their register Numbers will be deleted from the Short List without further notice, if they fail to produce the Non-Creamy Layer Certificate/ Community Certificate.

7. Candidates included in the Short List are directed to submit the copies of their certificates to prove name, date of birth, community and educational qualification within 7 days from the date of publication of the short list, either by post or in person to this office.

8. The place, date and time of interview will be intimated in due course.

9. According to the existing procedure, revaluation of answer scripts is not allowed. But candidates can apply for the rechecking of their answer scripts only after publication of the Select List.
