3. The candidates who have secured 72 marks and above are included in the Main List of the Short List. The required marks have been lowered to the extent necessary in respect of the Supplementary Lists.

4. The candidates belonging Other Backward Classes included in the Short List who are required to produce Non-Creamy Layer Certificate as per G.O(P) No: 81/09/SC/ST/DD dated 26.09.2009 shall produce the same along with other documents mentioned above as and when called for. Such candidates in the main list who fail to produce the required Non-Creamy Layer Certificate will not be entitled to the benefit of Community reservation and will be considered as Open Competition candidates.

5. SC/ST candidates included in the Short list are required to produce 2 copies of self-attested Caste Certificate obtained from the Revenue Authorities not below the rank of Tahsildar issued to produce before Kerala Devaswom Recruitment Board. Such candidates in the List who fail to produce the required community certificate will not be entitled to the benefit of Community reservation and will be considered as Open Competition candidates.

6. As regard to such candidates in the Supplementary Lists of Other Backward Classes, Schedule Caste and Schedule Tribe, their register Numbers will be deleted from the Short List without further notice, if they fail to produce the Non-Creamy Layer Certificate/ Community Certificate.

7. Candidates included in the Short List are directed to submit the copies of their certificates to prove name, date of birth, community and educational qualification within 7 days from the date of publication of the short list, either by post or in person addressed to The Secretary, KERALA DEVASWOM RECRUITMENT BOARD, Vth Floor, Devaswom Buildings, near Govt: Ayurveda College, MG Road, Thiruvananthapuram 695001.
8. The place, date and time of interview will be intimated in due course.
