Note: 1. Inclusion of Register Numbers in this list is purely provisional subject to scrutiny and admission of applications on absolute basis. 2. The Short List is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

3. The candidates who have secured 64 marks and above are included in the Main List of the Short List. The required marks have been lowered to the extent necessary in respect of the Supplementary Lists.

4. The candidates belonging to Other Backward Classes included in the Short List who are required to produce Non-Creamy Layer Certificate as per G.O(P) No: 81/09/SC/ST/DD dated 26.09.2009 shall produce the same along with other documents mentioned above or as and when called for. Such candidates in the main list who fail to produce the required Non-Creamy Layer Certificate will not be entitled to the benefit of Community reservation and will be considered as Open Competition candidates.

5. SC/ST candidates included in the Short list are required to produce 2 self-attested copies of Caste Certificate obtained from the Revenue Authorities not below the rank of Tahsildar issued to produce before Kerala Devaswom Recruitment Board. Such candidates in the List who fail to produce the required community certificate will not be entitled to the benefit of Community reservation and will be considered as Open Competition candidates.

6. As regard to such candidates in the Supplementary Lists of Other Backward Classes, Schedule Caste and Schedule Tribe, their register Numbers will be deleted from the Short List without further notice, if they fail to produce the Non-Creamy Layer Certificate/ Community Certificate.

7. Candidates included in the Short List are directed to submit self-attested copies of their certificates to prove name, date of birth, community and educational qualification within 7 days from the date of publication of the short list, either by post or in person addressed to THE SECRETARY, KERALA DEVASWOM RECRUITMENT BOARD, AYURVEDA COLLEGE Jn., THIRUVANANTHAPURAM 695001.

8. The place, date and time of interview will be intimated in due course.

9. According to the existing procedure, revaluation of answer scripts is not allowed. But candidates can apply for the rechecking of their answer scripts only after publication of the Select List.


