ADDENDUM NOTIFICATION

Sub: Ranked list of LD Clerk/Sub Group Officer Gr II in the Travancore Devaswom Board-Addendum Notification -Reg.

It is here by notified as follows.

Smt. Dhanya S, Vaikundam, Pooncode, Bhagavati Nada Post, Thiruvananthapuram, a candidate included in the probability list for the post of Lower Division Clerk/ Sub Group Officer Grade – II in Travancore Devaswom Board published on 01.11.2019 failed to appear for Certificate Verification. Hence, her name was not included in the Ranked List for the post of Lower Division Clerk/ Sub Group Officer Grade – II in Travancore Devaswom Board published on 26.02.2020. Her request on 29.02.2020 for giving her an opportunity to appear before Kerala Devaswom Recruitment Board to produce the original documents so as to include her name in the Ranked List was rejected by the Board as the ranked list for the post was finalised and published on 26.02.2020. Aggrieved by the decision of the Board, she filed Writ Petition No. 7537 of 2020 before the Hon'ble High Court of Kerala.

The Hon'ble High Court directed the Recruitment Board to reconsider the case of the petitioner in the light of the marks secured by the petitioner, along with the circumstances under which she was disabled from producing the documents for verification, considering her age also.

On the basis of the direction of Hon'ble High Court in WP(C) No.7537 of 2020, the case of Smt. Dhanya S was taken up for reconsideration. The Board took note of the fact that she secured 84.34 marks in the written examination ie, above the cut off mark and that she is well qualified academically and is now aged 37 years and unemployed. Though the non inclusion in rank list is solely attributable to the fault of the candidate, the Board found that justice demanded a reconsideration of the case on sympathetic grounds taking a lenient view. Hence, the Board decided to assign Smt. Dhanya S her due rank and to advise when her turn comes up.

In the above circumstances it is hereby notified that, the name of Smt. Dhanya S (Register number: 112790) is added to the main list of the Ranked list No.01/2020 dated 26.02.2020 for the post of LD Clerk/Sub Group Officer Gr II in the Travancore Devaswom Board. She is placed as Rank No.125A, in between Rank No.125 and Rank No.126

Accordingly the revised entries in the Ranked List shall read as follows


