It shall be produced along with other documents mentioned in Para 8. **Such candidates in the Main Lists who fail to produce the required Certificate to prove that they belong to Economically Weaker Sections of Hindu Unreserved Communities will not be entitled to the benefit of EWS reservation and will be considered as Open Competition Candidates.**

**5:** Candidates belonging to Other Backward Classes included in the Probability lists who are required to produce Non-Creamy Layer Certificate as per GO (P) 81/09/SC/ST/DD dated 26.09.2009 shall produce the same along with other documents mentioned in Para 9. **Such candidates in the Main List who fail to produce the required Non-Creamy Layer Certificate will not be entitled to the benefit of Community reservation and will be considered as Open Competition candidates.**

**6:** SC/ST candidates included in the Probability list are required to produce 2 copies of self-attested Caste Certificate obtained from the Revenue Authorities not below the rank of Tahsildar issued to produce before Kerala Devaswom Recruitment Board. **Such candidates in the List who fail to produce the required community certificate will not be entitled to the benefit of Community reservation and will be considered as Open Competition Candidates.**

**7:** As regard to such candidates in the Supplementary Lists of EWS, Other Backward Classes, Scheduled Castes and Scheduled Tribes, their register Numbers will be deleted from the probability List without further notice, if they fail to produce the EWS Certificate/ Non-Creamy Layer Certificate/Community Certificate.

**8:** Candidates included in the Probability List are directed to appear in person for verification of original documents on **23.02.2021** with self attested copies of their certificates to prove name, date of birth,
