3: The Candidates belonging to the Economically Weaker Sections of Hindu Unreserved Communities(EWS) included in the Short List are required to produce a Certificate from Village Officer concerned as per **GO(P) No.79/2019/RD dated 18.11.2019**, to prove that they belong to Economically Weaker Sections of Hindu Unreserved Communities. Such candidates who fail to produce the required EWS Certificate will not be entitled to the benefit of Community reservation and will be considered as Open Competition candidates

4: Candidates belonging to Other Backward Classes included in the Short List who are required to produce **Non-Creamy Layer Certificate** as per **GO(P)81/09/SC/ST/DD dated 26.09.2009** shall produce the same along with other documents mentioned above or as and when called for. Such candidates who fail to produce the required Non-Creamy Layer Certificate will not be entitled to the benefit of Community reservation and will be considered as Open Competition candidate.

5: Scheduled caste and Scheduled Tribe candidates included in the Short List are required to produce **2 self-attested copies of Caste Certificate** obtained from the Revenue Authorities, not below the rank of Tahsildar. Such candidates in the List who fail to produce the required caste certificate will not be entitled to the benefit of Community reservation and will be considered as Open Competition Candidates.
