THE KERALA DEVASWOM RECRUITMENT BOARD
(AMENDMENT) REGULATIONS, 2021

Dated, Thiruvananthapuram, 3rd May, 2021
20th Medam, 1196

In exercise of the powers conferred by Section 17 of the Kerala Devaswom Recruitment Board Act, 2015 (16 of 2015) and with the previous sanction of the Government, the Kerala Devaswom Recruitment Board hereby make the following regulations further to amend the Kerala Devaswom Recruitment Board Regulations, 2016 issued on 20th February, 2016, namely:-

REGULATIONS

1. *Short title and commencement.*- (1) These regulations may be called the Kerala Devaswom Recruitment Board (Amendment) Regulations, 2021.

(2) They shall come into force at once.

2. *Amendment of the Regulations.*- In the Kerala Devaswom Recruitment Board Regulations, 2016, after Chapter 7

(1) in ANNEXURE I, under the heading 1. 'List of Hindu Scheduled Castes in Kerala State', --

(i) for the existing entry against item 37 "Pulluvan", the following entry shall be substituted, namely:-

"Palluvan, Pulluvan";

(ii) for the existing entry against item 47 "Thandan (Excluding Thandans of Palakkad and Thrissur Districts)" the following entries shall be substituted, namely:-

"Thandan (excluding Ezhavas and Thiyyas who are known as Thandan, in the erstwhile Cochin and Malabar areas) and (Carpenters who are known as Thachan, in the erstwhile Cochin and Travancore State), Thachar (other than Carpenter)" ;

(2) in ANNEXURE II under the heading 'LIST of Hindu Other Backward Classes in Kerala State', --

(i) under the sub-heading "I. Throughout the State" against item 55 for the existing entry "Thachar", the following entry shall be substituted, namely:-

"Thachar who are Carpenters";

(ii) under the sub-heading "III. Throughout the State Except Malabar District", the existing entry against item 2. "Malayan" shall be omitted.
