In exercise of the powers conferred by section 18 of the Kerala Devaswom Recruitment Board Act, 2015 (16 of 2015), the Government of Kerala hereby make the following rules further to amend the Kerala Devaswom Recruitment Board Rules, 2015 issued by



notification under G.O.(P)No. 216/2015/RD. dated 30th May, 2015 and published as S.R.O. No.352/2015 in the Kerala Gazette Extraordinary No.1303 dated 30th May, 2015, namely:-

1. *Short title and commencement.*- (1) These rules may be called the Kerala Devaswom Recruitment Board (Amendment) Rules, 2026.

(2) They shall come into force at once.

2. *Amendment of the Rules.*- In the Kerala Devaswom Recruitment Board Rules, 2015, in sub-rule (3) of rule 3, the following sentence shall be added at the end, namely:-

“Rules 28 to 30 of Part II of the Kerala State and Subordinate Service Rules, 1958 shall be applicable mutatis mutandis in the proceedings of the Departmental Promotion Committee and in the preparation of the Select List.”

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The Kerala Devaswom Recruitment Board Rules, 2015 was issued as per notification under G.O.(P) No.216/2015/RD. dated 30th May, 2015 and published as S.R.O.No.352/2015 in the Kerala Gazette Extraordinary No.1303 dated 30th May, 2015. As per sub - rule (3) of rule 3 of the Kerala Devaswom Recruitment Board Rules, 2015, the candidates for appointment to the selection categories and grades of the service shall be chosen by the Departmental Promotion Committee constituted by the Kerala Devaswom Recruitment Board. As there are no provisions regarding the proceedings of the said Committee and preparation of Select List in the Rules, the Kerala Devaswom Recruitment Board has recommended the Government to amend the said rules by incorporating the relevant provisions of the Kerala State and Subordinate Service Rules, 1958. Hence, the Government have decided to amend the Kerala Devaswom Recruitment Board Rules accordingly.

The notification is intended to achieve the above object.
